

DESCRIPTION

mounted as a long handscroll with a brocade cover, from a set of domestically produced copper-plate engravings commemorating the Emperor's military victory in East Turkestan from 1826-1835, depicting various battles on mountainous terrain or by fortified villages, surrenders of the enemy, and a palace reception honoring the victors, some inscribed with Imperial poems dated the first month of 1829

The engravings are entitled:

- 1. Battle at the Honbasi River
- 2. Battle at Korping
- 3. Battle at Yangi-arbat
- 4. Battle at Sabdul-zhuang
- 5. Battle at Awabat-zhuang
- 6. Reconquest of Kashgar and Capture of the Rebel Leader
- 7. Reconquest of Khotan and Capture of the Rebel Leader, Garla

8. Capture of the Rebel Leader, Jahangir, at the Hartagai Mountain9. Presentation of prisoners of war at the Wumen Gate10.Victory banquet for officers in the Zhengda Guangmingdian

CATALOGUE NOTE


Complete sets of Daoguang's military conquest of Turkestan in 1830, also known as *Qingding pingding Huijiang jiaoqin niyi fanglüe*, are the rarest of the eight imperially commissioned battle engravings and the final group ever produced. Only sixty sets were produced in 1830 and given only to princes and high officials. Of those engravings produced domestically, scholars consider the 1830 set to be the best in quality. (The engravings for the First Turkestan Campaign commissioned under the Qianlong emperor were produced in France from 1767-1774).

In 1826, Jahangir, a scion of an ousted ruling family from East Turkestan began a staging a holy war against the Qing. The Daoguang emperor responded in 1827 by sending General Changling and 22,000 troops to reconquer the city of Kashgar and to capture Jahangir. Jahangir escaped but was later betrayed and sent to Beijing, where the Daoguang emperor had him ritually presented at the Imperial Ancestral temple before he was quartered.

(The Drafts of the Battle Engravings of the Qianlong and Daoguang period.), *Monumenta Serica*, vol. 9, 1944, pp. 101-122, mentions four existing sets of Daoguang engravings (p. 119, footnote 83): one in the collection of Luo Zhenyu, one in the Dairen Library, one in the *Peking jimbun kagaku kenkyûsho*, and one in his own collection.
